PRE-BID REQUESTS FOR INFORMATION

RFI 01: After reviewing the bid docs for this project I noticed the "Supplemental Bid Form" has an (*) by it in the Table of Contents somewhat indicating it is a required bid form. The actual form shows "DO NOT USE THIS FORM-NOT APPLICABLE FOR THIS PROJECT." Please confirm we should remove page 23 of 114 - Supplemental Bid Form from our bid submission. We just want to make sure.

RFI 01 Answer: Supplemental Bid Form is not required

RFI 02: Just wanted to confirm the Bid Form will be revised to remove the N/A currently printed on the Add Alternate line/box.

RFI 02 Answer: Correct, revised bid form is attached in this addendum – refer to ADD1-01.

RFI 03: Special Conditions: Section F. License Classifications C10 or B?

RFI 03 Answer: General Contracting B and/or Painting C-33

RFI 04: How many locker doors for replacement should we include in our bid and what size doors? Per Summary of Work "coordinate with CM any doors deemed irreparable to replace with new". For bidding purpose we should assume some number of doors and their sizes.

RFI Answer 04: No doors will be replaced at this time.

RFI 05: Can you provide more details in reference to the required "Paint stripe on drywall above tile wall in both locker rooms" and "Paint stripe on drywall above tile wall in both gym lobby restrooms" - how many walls are getting the stripe, size, etc.?

RFI 05 Answer: Striping shall be included in bid as an additive alternate. Striping to match main gym and both be applied to all walls in main portion of locker rooms and lobby restrooms. Color selection to be approved by the District through the CM. Refer to question/answer in RFI 07 below.

RFI 06: There is a discrepancy about the guarantee of the work you are asking...Please see the two pages which conflict. In the specs you call out for one year and the other for two years. Please Clarify what is the warranty/guarantee period you want?

RFI 06 Answer: Please replace the verbiage on pg. 67, Article 16 item a of Document 00500 Contract to say "Besides guarantees required elsewhere, Contractor shall, and hereby does, guarantee all work for a period of one (1) year after date of acceptance of work by the District.

RFI 07: Please confirm that the team room scope will be part of the original bid or Alternate.

RFI 07 Answer:

On section 011000 Summary Of Work sub-section 1.02 A. 2 replace the verbiage to read "This Prime Contractor is to accurately locate and provide all Painting scope of work for the entire project, including but not necessarily limited to the following:

Locker Room/Locker room Hallways: Paint all doors and frames (5) sided at interior hallway, locker rooms, and all door/window frames at locker room offices. Paint exterior doors and frames (5) sided, paint walls and ceilings in locker rooms, paint walls in interior hallways (neutral color).

Gym Lobby Restrooms: Paint walls and ceiling in gym lobby restrooms (neutral color). Paint doors/frames (interior side).

Dance Room: Paint walls and ceiling in dance room/boys team room (neutral color). Paint doors and frames (5) sided.

Gym: Paint basketball apparatuses in gymnasium (neutral color).

Team Room: Paint walls and ceiling at boys' team room (neutral color). Paint doors and frames (5) sided.

Additive Alternate: "Prep: all Sanding, Priming and Paint, remove doors & old hardware as necessary, straighten metal and remove rust in the Boys' Team Room. Striping shall also be included in bid as an additive alternate. Striping to match main gym and both be applied to all walls in main portion of locker rooms and lobby restrooms. Color selection to be approved by the District through the CM.
