# **PRE-BID REQUESTS FOR INFORMATION**

RFI 01: Per Addendum 1, sheet 1-104 detail 5 notes to scrap and remove existing wall coatings, roughen & grind for proper adhesion, patch and repair all voids and cracks and so on. With our experience this will take extensive sand blasting. The existing walls have multiple coats which are very thick which are hiding all the voids, bug holes and cracks, in addition we are unable to truly see what has been sacked and patched which will also blow out during the extensive sandblasting that will be required. Are thoughts are that the entire building could possibly need to be skimmed with Sikaflex. We are asking that there be an allowance allocated for unforeseen items which are not apparent until sandblasting has been completed.

RFI 01 Answer: There is an owner allowance of Eighty Thousand Dollars \$80,000.00 to cover unforeseen conditions specific to exterior water proofing measures. Architect to review areas of concern after sand blasting and advise how to proceed with patching and repairs.

RFI 02: Received substitution request from Johns Manville reference section 075216 – SBS Roofing System.

RFI 02 Answer: The substitution request has been rejected. This response is based on the Oceanside USD Board approved Resolution No. 34 (20-21) designating The Garland Company as the roofing standard for the District.

RFI 03: After reviewing the bid docs for this project I noticed the "Supplemental Bid Form" notes El Camino High School and has an (\*) by it in the Table of Contents somewhat indicating it is a required bid form. Please confirm the form will be revised and needs included in our bid submission.

RFI 03 Answer: The reference to ECHS is an administrative error. The supplemental Bid Form is not required for this project.

RFI 04: Confirming the Bid Form will be revised to remove the N/A currently printed on the Add Alternate line/box.

RFI 04 Answer: Correct, revised bid form is attached in this addendum – refer to ADD1-01. Refer to the plans – A 103.1 (Addendum #1) Note #10.
