The Oceanside Unified School District is soliciting Materials Testing and Inspection Services proposals for the following public works projects.

Project Names:

 Surfside Educational Academy Campus Modernization Increment #1, Project No. 801-735

Scope:

The scope of services shall include, but not necessarily be limited to, materials testing and special inspection services in accordance with the DSA 103 form. Coordination with the District, Architect, Project Management, Contractor, and Inspector of Record for scheduling for testing. Firms will include attendance to Owner/Architect/Contractor weekly meetings, daily reports of inspections regarding status of work inspected, deficiencies, photos, and remedies when executed, and assist with final reporting for project closeout with DSA.



The work is scheduled to tentatively begin June 24, 2024 and the completion date is anticipated to be September 27, 2024. Estimated duration of the project is 3 months; however, please include one (1) month for pre-construction DSA document submittal and one (1) month for DSA closeout. Construction budget is \$23.3M.
