The Oceanside Unified School District is soliciting Geotechnical Services proposals for the following public works projects.

Jefferson Middle School Modernization Phase 1, Project No. 858-710

Scope:

The scope of services shall include, but not necessarily be limited to, geotechnical soil sampling and laboratory testing, geotechnical engineering evaluation, performance of site soils investigations, geotechnical required testing of sub and finished grades, daily reports of testing and results, final reporting, and assisting with DSA closeout for inspection with coordination with the DSA Inspector of Record for this project.

The work is scheduled to tentatively begin June 7, 2024, and the completion date is anticipated to be August 14, 2024. The estimated duration of the project is 2 months; however, please include one (1) month for DSA closeout. Construction budget is \$33.2M.
